ARTICLE 9.2 AMENDMENT AND MODIFICATION OF THE PLAN

Section 9.2.1 Amendment of the Comprehensive Plan: A Plan Amendment shall only be initiated by formal action of the City Commission. Generally there shall be two amendments each year. One amendment shall be initiated in the early portion of each calendar year and shall include changes developed pursuant to Part V.B of the Comprehensive Plan. The other amendments shall be initiated in the month of June and shall focus upon individual development items and changes to the Future Land Use Map. The purpose and content and method of review of amendments to the Comprehensive Plan shall be made pursuant to F.S. 163.3187 and 163.3177(3)(b), as appropriate.
