- Radios and amplified music must be approved prior to the event through a written request and approved prior to the date of the event.
- General set-up will be done by the staff, however, breakdown and disposal for trash will be done by the applicant.
- Grills, glass containers, alcoholic beverages or smoking on the pool deck is not permitted at either aquatic facility. Guests are to abide by all Pool Rules and Regulations when swimming at either aquatic facility.

Facility Fees and Deposit

Aquatic Facility Rental Rate is \$100.00 for the first three (3) hours and \$35.00 for each additional hour after. This fee includes (2) certified lifeguards on site during your event. Groups over 50 will require an additional Lifeguard at \$25.00 per hour for each additional (25) guests. *Lifeguard / Patron Ratio: 1 / 25.*

A \$50.00 (cash only) deposit upon contract approval to reserve dates is mandatory and will be refunded upon inspection of the facility after the event. An applicant is responsible for damage to City equipment and property.

This application should be submitted for approval at least three (3) weeks prior to the event. Fees must be paid at least two weeks prior to the event. Fees may be refunded if one week's notice of cancellation is received.

The City of Delray Beach may, at its option, cancel the use requested by applicant. Such notice of cancellation, whether written or oral, shall be given to the contact person named above no later than seven days prior to the scheduled event. In the event the City cancels an event, the applicant is entitled to the return of any deposits as liquidated damages.

RELEASE WAIVER
